BOMA MEMBERSHIP CATEGORIES

1. **Principal Membership** - Held by members owning, developing, managing, leasing, controlling or otherwise directly involved in commercial property in the Tennessee Valley area. This member has the right to vote and hold office and also includes membership to BOMA International. All firms must have a minimum of one membership to BOMA International through the Tennessee Valley Association of BOMA.
2. **Additional Membership** - Additional associates of the Principal Member's firm. (Firms must have one local "Principal Membership".)
3. **Allied Membership** - Firms which have a direct interest in real estate in which Principal Members are involved, providing goods or services, i.e., contractors, suppliers and manufacturers. This includes membership to BOMA International. All firms must have a minimum of one Allied membership thru the Tennessee Valley Association of BOMA.
4. **Allied Secondary Membership** - Additional associates of an Allied Member's firm. (Firms must have one local "Allied Membership".)
5. **Professional** – Shall be a designated licensed attorney, registered engineer, licensed leasing agent and broker, licensed architect or interior designer whose principal practice includes the field of commercial real estate. This includes membership to BOMA International.
6. **Government** - Shall be federal, county, city or state agencies owning, developing, managing, leasing, controlling commercial property in the state. This includes membership to BOMA International.
7. **Life** – Retired past BOMA members as approved by the BOMA membership.
8. **Honorary** – Granted to those who render distinguished service to the Association and as approved by the Board of Directors.

MEMBERSHIP DUES
